Legal Warnings and Requirements:

1. Read carefully. These are the legal warnings and requirements for registering your child in school.
2. You must check that you have read them to continue on the system.

READ CAREFULLY

Schools are assigned on the basis of residential address for grades k - 12 . Documents are required at time of registration to establish eligibility to attend school. If you have any difficulties providing the required documents, please contact the school's attendance clerk for assistance with registration.

Proof of residence in the Pasadena Independent School District

Two acceptable documents include the following:

Current Deed, Mortgage / Mortgage Payment Book, Lease, or Rental Agreement

AND

Current Utility Bill (water, gas, electric, land-line phone)

Proof of child's age and identity

Acceptable documents include the following:

Original or certified copy of birth certificate

Passport

Military identification

Adoption record

Hospital birth record or

Any other legal document that establishes identity

Record of Immunizations

Records showing child is current on all required immunizations.

Other Documents Requested

Social Security Card

School Records - Withdrawal Form or Report Card, and the name, address, and phone number of the school

Falsification of Information

WARNING: The Texas Education Code 25.001(h) and the Texas Penal Code 37.10 provide penalties for falsifying school district records. The criminal penalty is a Class C misdemeanor with a maximum fine of up to \$500.00. In addition, monetary penalties may be assessed. A person who knowingly falsifies or provides misleading information on a form required for enrollment of a student in school district is liable for (1) the maximum tuition fee, or (2) the amount the district has budgeted for each student as maintenance and operating expenses. If the district determines that a child is not entitled to membership in the Pasadena ISD because of residence, the student will be immediately withdrawn and the parent or guardian may be billed at a rate of \$28.00 for every day the child was in illegal residence.

WARNING

ADDRESS CHANGES MUST BE REPORTED TO SCHOOL IMMEDIATELY. NEW PROOF OF RESIDENCY IS REQUIRED. FAILURE TO REPORT A CHANGE OF ADDRESS IS A FORM OF FALSIFICATION AND MAY RESULT IN TUITION CHARGES AND/OR CRIMINAL CHARGES.
